



Global Outreach Team/Vision Team Agreement Form

In consideration of my participation in *Horizon International's* Global Outreach (GO) Team and/or Vision Team ministries in Africa, I hereby agree to the following:

Health and Safety

Prior to travel, it is my/our responsibility to consult my/our family physician regarding immunizations or other precautions to protect against travel-related illnesses.

If I/we have any physical or mental condition or I/we are taking a prescription medication which may require special medical attention or accommodation during the GO Team or Vision Team, I/we will notify the offices of *Horizon International* or my/our group leader.

It is my/our responsibility to be sure I/we are covered by a policy of comprehensive health and accident insurance that provides coverage for any injuries or illnesses I/we may experience during my/our travel. I/we further agree to accept a supplementary policy provided by *Horizon International* which covers international travel medically related issues.

I/we will not hold *Horizon International*, its directors, or officers liable for any injuries, illnesses, claims, damages, charges, bills, and/or expenses I/we may incur related to health or accident issues while traveling through this ministry.

I/we grant to *Horizon International* or any of its representatives full authorization to take any action deemed necessary to protect my/our health and safety at my/our expense, including, but not limited to, placing me/us under the care of a doctor or hospital for medical examinations and/or treatment, or returning me/us to the United States if such return is deemed necessary after consultation with medical authorities.

Ministries and Travel

I/we understand that *Horizon International* reserves the right to make changes to the GO Team/Vision Team at any time and for any reason, with or without notice, and *Horizon* shall not be liable for any loss to me/us because of any such cancellation or change. Any additional expenses resulting from penalties assessed by airlines because of operational or itinerary changes is my/our responsibility.

Horizon reserves the right to substitute housing of a similar category at any time. Specific room and housing assignments are at the sole discretion of *Horizon*.

I/we agree that *Horizon International* may use video and/or photographs that may be taken of me/us during the period of my/our participation in the GO Team/Vision Team for whatever purposes it wishes. I/we understand that *Horizon International* assumes no responsibility, liability, or expense for any delays, cancellations, fare changes, missed carrier connections, public health risks, accidents, illnesses, injuries, death, losses, damages, or negligence by any tour operator, airline, or transportation company, hotel or other housing facility, food service, or any other service due to weather, strikes, acts of God, war, quarantine, civil unrest, terrorism, or any other reason not explicitly stated here.

I/we realize that *Horizon International* cannot assume responsibility for any loss, disappointment, expense, or frustration resulting from my/our failure to follow instructions or obtain the required documentation including passport, visa, birth, and/or health certificates.

I/we understand that *Horizon International*, at its sole discretion, reserves the right to cancel all or part of any program after departure, requiring that all participants return to the United States if *Horizon* determines or believes that any person is or will be in danger if the global outreach is continued.

I/we understand that baggage loss or damage sustained while in the custody of an airline, hotel, bus company, transfer company, or *Horizon International* vehicle is not the responsibility of *Horizon International*.

I/we also understand that I/we may purchase insurance through the offices of *Horizon International* to cover baggage loss or damage. (Again, very reasonable in cost and considered over-and-above trip quotes.)

Conduct and Lifestyle

I/we understand that *Horizon International* reserves the right not to accept or retain me/us on the GO Team/Vision Team at any time should my/our actions or behavior impede the operation of *Horizon's* ministries or the rights or welfare of another person. In such an event, no refund will be made for any unused portion of the GO Team/Vision Team.

I/we acknowledge that my/our participation in Horizon International's GO Team/Vision Team is entirely voluntary.

I/we acknowledge that I/we have read, understand, and will abide by each of the terms and conditions of this agreement. I/we realize that all deposits are nonrefundable and cannot be transferred to another person.
